Fund Overview

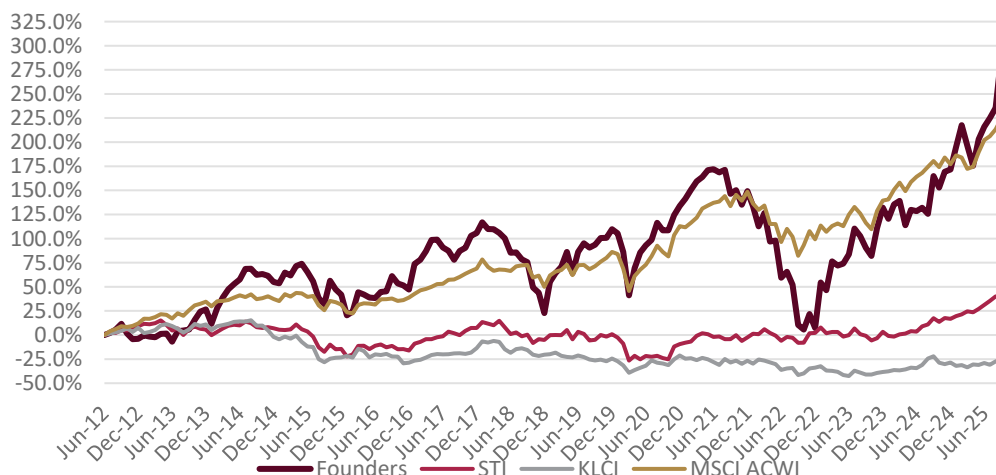
MTC Founders Fund (“MTC” or “the Fund”) is an actively managed global listed equities fund. The Fund is a bottom-up, value driven, absolute return focused fund with a strong emphasis on capital preservation and downside protection. The Fund primarily invests in large-cap companies, with market capitalisations well over US\$1 billion. The Fund is largely invested in companies listed in the US and Emerging Asia. The Fund does not time markets, engage in momentum trading or rely on market forecasts to deliver high risk-adjusted returns.
